

## California Water Service Group Board of Directors Declares 297th Consecutive Quarterly Dividend

SAN JOSE, Calif., April 24, 2019 (GLOBE NEWSWIRE) -- At its meeting today, the California Water Service Group (NYSE: CWT) Board of Directors declared the company's 297<sup>th</sup> consecutive quarterly dividend in the amount of \$0.1975 per common share.
