

## California Water Service Group Awards \$60,000 in Scholarships to Students in Its Service Areas

Two grand-prize recipients, Fariha Hameed from Westlake Village, Calif. and Sophia Leiker from Chico, Calif., were recognized for their outstanding academic achievement and community service.

Of Leiker, Assembly Member Gallagher, who represents the 3<sup>rd</sup> Assembly District, including Cal Water's Chico service area, said, "I was honored to join Ms. Leiker this morning as she was awarded a \$10,000 scholarship from Cal Water. To be eligible for a scholarship, students must live in a Cal Water service area, plan to enroll in full-time undergraduate study at an accredited two- or four-year college or vocationaltechnical school, and not already possess a degree or diploma from an accredited two- or four-year college or vocational-technical school. The next scholarship cycle will open in spring 2016 for students pursuing higher education in the fall of 2016.
